For Publ Health Depts. – at health.personcounty.net – key points – health data – death rate – leading cause of death 2001-05 – heart, cancers, storke, chronic reps. Dis – motor veh. – diabetes, pneu., kidney, suicide. Males 57% higher than females . death rate higher for males – total rate for minorities 13% higher than whites. 936 new cases of cancer 2000-04;

Comm. Health Survey – 671 participants – cancer, hd, obesity, diabetes, problems with aging. Most unhealthy – alco., tobacco, ----;

Community issues: unemployement, gang activities, affordiability of health ser, low income, droppoing out of school, health ins, neglect & abuse, lack of facilites.
