The Board of Commissioners for the County of Person, North Carolina, met in recessed session on Tuesday, November 27, 2007 at 7:00 p.m. in the Auditorium of the Person County Office Building.

Also a request to Consider Alternative Sites and Socioeconomic Demographic Data for a Proposed Expansion of the Upper Piedmont Environmental Solid Waste Landfill.
